Forum flays attacks on construction firm

THE Uyo Youth Elders Consultative Forum has frowned at what it describes as unprovoked and senseless attack on a major construction firm in Akwa Ibom State.

The forum said in a statement by its Mr. Itoke Okun and the Secretary, Mr. C. E. Ekong that the attack directed at one of the construction firms, the Chinese Civil Engineering Construction Company CCECC, was malicious and cheap handiwork by some greedy politicians.

The statement said: "We have found out that the publications are sponsored by some fraudsters who have chosen to embark on actions that will negatively affect the process of transformation being engineered by Governor of Akwa Ibom State."

"In the past couple of weeks, we have been reading these outrageous falsehood and campaign of calumny by some people of questionable character. Several of these allegations are frivolous and childish while others are exaggerated or blown out of proportion. The intention and direction of sponsors of the publications are clear: they are bent on maligning and destroying the integrity of the Company, after they failed in their bid to intimidate its management to cough out some money to them."

The statement added that the uncommon feat and friendly disposition of the Chinese Civil Engineering Construction Company was responsible for patronage by the State Government which awarded another road contract to it.
