  - **Refund of Tuition Fees would only be allowed under the following conditions :**
    - ❖ **Before resumption of lectures – 80% of tuition fees may be refunded**
    - ❖ **After resumption of lectures (i.e. within 6 weeks) – 50% of tuition fees may be refunded**
    - ❖ **After resumption of lectures (i.e. 6 weeks and beyond) – No Refund**
    - ❖ **When deferment is granted – No Refund**
